## Subject- E-voting Particulars relating to the Extra-Ordinary General Meeting

- (a) Please take note that Notice of the Extra-Ordinary General Meeting (EGM) of the Company scheduled on 22<sup>nd</sup> February 2019 has been sent to the shareholders in permitted mode whose names stood registered in the register of members as on 11<sup>th</sup> January 2019. - (b) Also take note that pursuant to the provisions of Regulation 44 of SEBI (LODR) Regulations, 2015 read with section 108 of the Companies Act' 2013 and rules framed thereunder the Company is providing the members the facility to exercise their vote at the EGM by electronic means and the business may be transacted through the remote e-voting services provided by Central Depository Services (India) Limited (CDSL). The remote e-voting period commences on Tuesday, 19<sup>th</sup> February 2019 at 10.00 a.m. and concludes on Thursday 21<sup>st</sup> February 2019 at 5.00 p.m. The remote e-voting module shall be disabled by the CDSL thereafter. Company has appointed Mr. Tarun Chatterjee, Advocate failing him Ms. Binita Pandey, Practicing Company Secretary as Scrutinizer to scrutinize the e-voting and ballot procedure in a fair and transparent manner.
